

**OLD WISCONSIN VIP TRAINING CAMP SWEEPSTAKES**  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING.**

The Old Wisconsin VIP Training Camp Sweepstakes (“Sweepstakes”) is sponsored Old Wisconsin Sausage, Inc. (“Sponsor”), 950 175th St., Homewood, IL 60430 and is administered by Prize Logic, LLC, (“Administrator”), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on June 1, 2020 at 12:00 PM Central Time (“CT”) and ends on August 31, 2020 at 11:59:59 PM CT (“Sweepstakes Period”). The Sweepstakes Period includes a grand prize drawing (“Grand Prize Drawing”) that runs the entire length of the Sweepstakes Period and three (3) entry periods (each an “Entry Period”) as outlined in the chart below:

Non-winning entries will carry forward into the subsequent Entry Period. The Administrator’s computer is the Sweepstakes official clock.

2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of one of Illinois, Iowa, Michigan, Minnesota, and Wisconsin who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, The Clorox Company, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, “Sweepstakes Entities”) and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the “steps” of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.

Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant’s residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.

3. **HOW TO ENTER THE SWEEPSTAKES: Make a Purchase:** There are two (2) ways to enter the Sweepstakes:

- A. Make A Purchase:** During the Sweepstakes Period, an eligible entrant may purchase an eligible specially marked Old Wisconsin or Kingsford product (see Appendix for eligible products) at any participating store, (“Qualifying Purchase”), while supplies last. Each Qualifying Purchase will have one (1) code (“Code”) printed on the peel-off sticker. Entrant must then visit [meatdavid.com](http://meatdavid.com) (“Website”) and complete and submit the registration form, including, but not limited to: his/her first and complete last name (no initials), phone number, city, state, and agreement to these Official Rules. The entrant must then follow the on-screen prompts and submit the Code. Codes

must be submitted by 11:59:59 PM ET on August 31, 2020 to be valid. It is strongly recommended that the entrant maintain possession of the original or photocopy. The entrant should not give a Code to any store employee. Upon approval of receipt, an entrant will receive one (1) entry into the applicable Entry Period and into the Grand Prize Drawing. There is a limit of one (1) Code submission per day during the Sweepstakes Period. A Code cannot be used more than one (1) time.

**B. Enter Without Making a Purchase:** To earn a Sweepstakes entry without making a purchase, an eligible entrant may visit <https://alternatemethodofentry.com/013542> and complete and submit the registration form. Then follow the links and instructions to save the registration form as a PDF with the barcode present. Then email the PDF to [AlternateEntry@prizelogic.com](mailto:AlternateEntry@prizelogic.com) by August 31, 2020. An entry via this method is worth one (1) entry into the applicable Entry Period and one (1) entry into the Grand Prize Drawing. An entrant may enter (1) time per day via this method during the Sweepstakes Period.

**Limit:** Regardless of method of entry, an entrant will receive no more than one (1) entry per day during the Sweepstakes Period. A “day” is defined as starting at 12:00 AM CT and ending at 11:59:59 PM CT on a calendar day during the Sweepstakes Period, except on June 1, 2020 when a day is defined as starting at 12:00 PM CT and ending at 11:59:59 PM CT. If more than the stated number of entries are received from the same person, telephone number and/or e-mail address, the entries may, at the Sponsor’s sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected that an entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that entrant, in Sponsor’s sole discretion, may be disqualified and not be eligible to win a prize. Subsequent attempts made by the same individual to submit multiple entries by using multiple or false contact information, accounts or otherwise may result in the entrant being disqualified. Entries generated by a script, computer programs, macro, programmed, robotic or other automated means are void and may be disqualified. Entries that are in excess of the stated limits, incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost, late or misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor’s sole and absolute discretion. Entries submitted by entrants who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void.

**4. RANDOM DRAWING:** On or around each date indicated in the chart above in Section 1, the Administrator will randomly select three (3) potential first prize winners from all eligible entries received for Entry Periods 1 and 2 and four (4) potential first prize winners from all eligible entries received for Entry Period 3, for a total of ten (10) potential first prize winners. On or around September 1, 2020, the Administrator will randomly select one (1) potential grand prize winner from all eligible entries received during the Sweepstakes Period. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

**5. PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:**

**A. Grand Prize (1):** The grand prize is an ultimate training experience (“Grand Prize”). Grand Prize

includes a one (1) night stay at a hotel selected by Sponsor in its sole discretion near Lambeau Field in Green Bay, Wisconsin during the 2020 Training Camp (date subject to availability – double occupancy hotel room); Hall of Fame passes for Sweepstakes Grand Prize winner and a guest of his/her choosing (“Guest”); VIP Stadium Tour passes for winner and Guest to attend and watch the Packer Training Camp, a ten (10) minute meet and greet with David Bakhtiari (subject to availability) and one (1) \$500 Packers Pro Shop Gift Card for the Grand Prize winner (terms and conditions of gift card apply). **Travel is not included in the Grand Prize. Grand Prize winner is responsible for all travel expenses, including ground transportation, lodging, meals, and parking, incurred in participating in the Grand Prize.** Grand Prize winner will be required to provide a major credit card upon hotel check-in, and all in-room charges will be charged to the credit card. Any damage to the room will be the responsibility of the Grand Prize winner. If the Guest is a minor, he/she must be the child or legal ward of the Grand Prize winner, and must remain with the Grand Prize winner at all times. Travel must occur as otherwise set forth by Sponsor, or the Grand Prize will be forfeited. Sponsor is not responsible if event is delayed, postponed, or canceled for any reason. Grand Prize winner will not receive compensation from Sponsor for tickets that the Grand Prize winner is unable to use due to cancellation of the event, but tickets may be subject to standard rain-check policies and procedures set by the issuer. Grand Prize winner agrees that event admission is awarded pursuant to a revocable, nontransferable license that is personal to that applicable Grand Prize winner, and may not be sold, resold, auctioned, bartered, assigned, exchanged, placed in commerce, transferred, given away, donated or otherwise conveyed. Sponsor reserves the right to remove or to deny entry to Grand Prize winner and/or his/her Guest if either Grand Prize winner or his/her Guest violates the previous restrictions or engages in a disruptive manner, or with intent to abuse, threaten or harass any other person at the event. No more than one (1) Grand Prize will be available in the Sweepstakes. The ARV of the Grand Prize is \$1,000.

**B. First Prizes (10 total; 3 for Entry Periods 1 and 2 and 4 for Entry Period 3):** Each first prize is a custom video shout out from David Bakhtiari (each a “First Prize”). Video customization is subject to David Bakhtiari’s discretion and may not include any thing offensive, inappropriate, hateful, fraudulent, defamatory, slanderous, libelous, indecent, or lewd and must not contain, facilitate, reference, or promote bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, gender, ethnicity, religion, nationality, disability, sexual orientation, political orientation, citizenship, ancestry, marital status, or age. Each First Prize winner will provide his/her requested video shout out message, however, final message may not be the exact message/script provided by winner. No more than ten (10) First Prizes will be available in the Sweepstakes. The ARV of each First Prize is \$40.

**C. Total ARV:** The total ARV of all prizes is \$1,400.

**D. Odds of Winning:** The odds of winning a First Prize depend on the number of eligible entries received during each Entry Period. The odds of winning the Grand Prize depend on the number of eligible Sweepstakes entries received during the Sweepstakes Period.

**E. General Conditions:** There is a limit of one (1) prize per person. In no event will more than one (1) Grand Prize and ten (10) First Prizes (three [3] for Entry Periods 1 and 2 and four [4] for Entry Period 3) be awarded. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes through a random drawing from among all eligible prize claims received.

**6. HOW TO CLAIM A PRIZE:** The potential winners are subject to verification of eligibility and

compliance with these Official Rules After the random drawing, Administrator will notify the potential winner via e-mail at the e-mail address provided at the time of registration. The potential Grand Prize winner will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within five (5) calendar days from the date of attempted notification or the Grand Prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor's sole and absolute discretion. The potential Grand Prize winner may be subject to a background check before the Grand Prize is awarded. Sponsor reserves the right to disqualify the potential Grand Prize winner based on the results of such background check if Sponsor determines in its sole discretion that awarding the Grand Prize to any such individual might reflect negatively on the Sponsor. Failure to provide all required information and a signature on the documents within the stated time period may result in forfeiture of a winner's right to claim his/her prize, and may result in the prize being awarded to an alternate winner, if time permits. If a potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, declines to accept a prize, the respective prize may be forfeited. If a prize is forfeited, the prize may be awarded to an alternate winner, selected in a random drawing from among all remaining eligible entries, as determined by Sponsor in its sole discretion. If, after a good-faith attempt, Sponsor is unable to award or deliver a prize, the prize may not be re-awarded. Upon verification of eligibility, the Grand Prize winner will be contacted to make arrangements for the Grand Prize and each First Prize winner will be contacted to provide his/her requests for the video shout out and once completed, each First Prize will be e-mailed to the winners at the e-mail address provided at the time of entry. Any portion of a prize not accepted by winner will be forfeited. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for his/her prize won. Sponsor will issue an IRS Form 1099-MISC for the Grand Prize winner. All other costs and expenses not expressly set forth herein shall be solely each winner's responsibility. The prizes will only be awarded to a verified winners.

Sponsor will attempt to notify each potential winner as set forth above, but Sponsor is not responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a winner's privacy or spam filter settings which may divert any Sweepstakes e-mail, including any winner notification e-mail, to a spam or junk folder. Prizes that are unclaimed, unredeemed, or returned as undeliverable will not be awarded. Prizes are non-transferable and no prize substitution, exchange or cash equivalent will be allowed, except by Sponsor, who reserves the right to substitute a prize of equal or greater value in case of unavailability of the prize or force majeure, at Sponsor's sole and absolute discretion. Sweepstakes Entities shall not be held responsible for any delays in awarding the prize for any reason.

LIMITATION OF LIABILITY:** By participating in this Sweepstakes, entrants agree that the Sweepstakes Entities and each of their respective affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers and each their respective officers, directors, stockholders, employees, representatives, designees and agents ("Released Parties") are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail/text notifications or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; (vii) any injury or damage, whether personal or property, to entrants or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting a prize; and (viii) entries that are

late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. Further, the Sweepstakes Entities are not responsible for any unanswered or undeliverable winner notifications.

IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS**

**AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
